## CONFERENCE DESCRIPTION

As heroin terrorizes our region, the nation and the global community, child advocates in many fields recognize the medical, mental health, educational and social emotional issues these children face. In partnership with the collaborative, Children of Addicted Parents, a conference to bring together the community of providers caring for these children will be held Friday, November 17<sup>th</sup>, 2017 at the Northern Kentucky Convention Center in Covington, Kentucky.

National and regional experts will address the issues affecting children exposed to opioids in utero or living with the chaos of being the child of a parent with substance abuse disorders.

- Discuss the future of neonatal abstinence syndrome and the long term outcomes of in utero exposure
- Discuss the psychosocial and mental health aspects of living with parents affected by a substance use disorder
- Discuss the educational issues of children affected by parental substance use disorder
