Course Description:

This course will focus on patient and family centered care with a focus in three specialty areas within the profession of speech-language pathology: neonatal abstinence syndrome, transgender voice, and anterior and posterior tongue tie.

Learner Outcomes:

Upon completion of this seminar, the participants will be able to:

- Describe the associations between cleft lip/palate and neonatal abstinence syndrome
- List ways to support family centered care when treating children with cleft/lip palate and neonatal abstinence syndrome
- Identify implications for transgender voice training versus surgical intervention
- Identify ways to evaluate quality of life and satisfaction post transgender voice therapy
- Identify the components of an anterior and posterior tongue tie and how it affects speech and swallowing for improved patient/family education
- List treatment strategies and referral options for a posterior tongue tie for family education

About the Presenter(s):

Shyla Miller, M.A., CCC-SLP, is a Speech-Language Pathologist II at Cincinnati Children's Hospital Medical Center. Her areas of interest include working with children and families impacted by cleft lip and palate, resonance disorders and speech sound disorders. Shyla also works in the Therapeutic Interagency Program through Cincinnati Children's Hospital Medical Center serving preschoolers with a trauma history of abuse, neglect, in-utero drug exposure, and/or placement into foster care.

John Fredeking, M.S., CCC-SLP, is a Speech-Language Pathologist at Cincinnati Children's Hospital Medical Center. He has been with the division since 2013. John's clinical interests include evaluating and treating voice disorders; transgender voice and communication training, and social-pragmatic language disorders. He is an active member in the Pediatric Voice Center. He established the Transgender Voice Clinic in 2017.

Marsha Lee, M.S., CCC-SLP, is a speech-language pathologist and certified orofacial myologist at the Cincinnati Children's Hospital Medical Center Mason Campus. Marsha has been providing speech and language evaluation and treatment services, oral-motor/feeding evaluations and treatment, as well as orofacial myology services for over 25 years.
