## **Family-Centered Approach for Children of Addicted Parents**

The Collaborative for Children of Addicted Parents (CCAP), GLAD House, and Cincinnati Children's invite session proposal submissions for the 3rd annual conference to be held November 14, 2018, at the Northern Kentucky Convention Center in Covington, KY.

Proposals are sought from authors representing a variety of backgrounds, perspectives, and voices. Submissions are encouraged regarding areas of family-centered practice, research, and relevant fields of discipline related to the theme, "Family-Centered Approach for Children of Addicted Parents." Anyone interested in presenting is encouraged to submit, including students, new professionals, and first-time presenters.

### Target Audience

Professionals caring for children impacted by addiction – including physicians, nurses, teachers, social workers, psychologists, advocates, lawyers, therapists, and intervention specialists.

### Theme

Proposals should explore family-centered practices utilized to provide services to children impacted by addiction.

#### Categories:

- Medical implications of substance use and the role of primary care providers
- Academic and social-emotional impacts
- The faces of child trauma and abuse
- Innovative programs for keeping families affected by addiction together
- Navigating family involvement with Children's Services and the court system

### Criteria

- Complete all submission requirements
- Relevance to the overall theme
- Originality of proposed topic
- Merit and clarity of the proposal, particularly having well-developed content and sufficient speakers to address the topic
- Diversity of the content and speaker representation
- Appropriate session content for proposed format
